## Terms and Conditions

### BETTER HOMES & GARDENS PUZZLE BOOK 28

#### **General**

1. Information on how to enter and prizes form part of the Terms and Conditions. Entry into this competition deems acceptance of these Terms and Conditions.
2. To the extent of any inconsistency between these Terms and Conditions and any other reference to this competition, these Terms and Conditions prevail.

#### **Who can enter**

3. Entry is open to ALL residents of **Australia and New Zealand** except employees and immediate families of the Promoter, associated companies and agencies and participating outlets.
